China Visa Application & Requirements for Bangladeshi

- Original Passport
 - Passport validity with minimum 8 months.
- Photographs
 - Recent photo (Size: 33x48mm)
 - NID Card Copy.
- Bank Documents
 - Bank statement (last 6 months & minimum balance 3 lac)
 - Bank solvency certificate
 - Tin Certificate
- Company NOC (for private service holders)
- Visiting Card
- Student ID Copy (for students)
- Marriage Certificate
- National ID Card or Birth Certificate
- TIN Certificate Copy *T&C apply
- **For Business Person:**
 - Trade License update (if have Bangla lease provide English translate with notary attached with Bangla copy)
 - Company pad
- **For Privet Service Holder:**
 - No objection certificate (NOC)

How long does China visa processing take?

Normally it takes approximately 10–15 working days, subject to CVASC and Embassy processing.

Is visa approval guaranteed?

No. Visa approval, validity, duration of stay, and number of entries are solely decided by the Embassy of China.

Can the Embassy ask for additional documents?

Yes. The Embassy or CVASC may request additional documents or an interview if required.

Do visa fees get refunded if the visa is refused?

No. Visa processing expenses and applicable service charges are non-refundable.
